Program Summary and Accreditation

The Dallas College School of Health Sciences offers an RN-BSN Nursing Program online. The program is designed for a Registered Nurse (RN) to complete the RN-BSN Program curriculum. The RN-BSN nursing program will focus on cultural diversity, and graduates will have the opportunity to earn a basic Spanish Interpreter certificate.

The Dallas College RN-BSN bachelor's degree prepares the registered nurse to function in a dynamic health care community delivering safe, high quality, evidenced-based and culturally sensitive nursing care to diverse individuals, families, and populations, with an emphasis on improving health outcomes within complex healthcare systems. This foundation provides for roles in management, leadership, and potentially a basic Spanish Interpreter certificate by allowing the student, as a self-directed learner, to continue with life-long learning in an ever-changing profession.

B. Application Requirements to the RN-BSN Nursing Program

1. Met the Dallas College admission standards for the RN-BSN degree program.
2. Submit all completed application materials to Allied Health Admissions during the designated filing period.
3. Submit official transcripts from all colleges and universities attended to demonstrate completion of at least 90 credit hours, including a minimum GPA of 2.5.
4. Evidence of a conferred Associate of Science degree in nursing from an accredited program of nursing (National League for Nursing Accrediting Commission [NLNAC] or Accreditation Commission for Education in Nursing [ACEN]).
5. Evidence of completion of the 42-hour Texas Core Curriculum
6. Hold a current unencumbered license as a registered nurse in the United States with proof of unencumbered current Texas license. Documentation must be submitted before coursework starts.
 - a. An applicant waiting to take the NCLEX-RN may be conditionally admitted. Conditionally admitted applicants must pass the NCLEX before starting RN-BSN curriculum course work.

8. Review General Dallas College [New Student Orientation video](#) and submit certificate of completion via CastleBranch
9. *Once Accepted into the program:* Submission of complete documentation of a current acceptable background check, urine drug test, physical exam, tuberculosis screening, required immunizations, health insurance, and CPR certification are required to be uploaded to CastleBranch.
10. Submitted acceptable urine drug test and criminal background check to CastleBranch.
11. Submit a professional reference from Nursing Supervisor/ Manager. Email to RNtoBSNProgram@DallasCollege.edu.

NOTE: Because the program will be delivered through online distance education, prospective international students will need to meet with the International Services Department to determine if they have the appropriate visa to meet SEVIS enrollment regulations.

C. General Admission Requirements to the College

Applicants to the RN-BSN Nursing program must meet all [college admission requirements](#) as outlined in the official college catalog and as outlined under the admission requirements.

Official College Transcripts

Prior to application to the RN-BSN Nursing program, potential applicants must have submitted **official transcripts from ALL colleges and universities the applicant has attended whether the coursework is or is not relevant to the program application.** Transcripts from Dallas College (formerly Dallas County Community College District) campuses are not required.

The transcripts must be current with the **print date no earlier than three years** prior to the applicant's anticipated admission to the program unless the student has not had a break in enrollment with Dallas College since the transcripts were originally submitted. If the official transcripts have not been submitted, the individual's application will be voided.

Official transcripts must be sent electronically from the applicant's previous colleges to studenttranscripts@dallascollege.edu. Transcripts sent by the applicant in pdf or other formats are not accepted. Transcripts may also be mailed from a college in a sealed envelope to Dallas College, Attn: Admissions Processing, 3737 Motley Drive, Mesquite, TX 75150.

Initial Advisement

Potential students are encouraged to meet with a [Success Coach](#) as a starting point toward future application to a health sciences program.

D. Prerequisite Courses

Applicants must have an Associate degree in Nursing and complete the prerequisite courses listed below with a minimum cumulative grade point average of 2.50 or higher to apply to the RN-BSN program.

Note: all prerequisite courses MUST be completed with a grade of C or better.

E. Previous coursework evaluation toward the RN-BSN program.

Official transcripts are fully evaluated by the Dallas College Transcript Evaluation Center after a student has been enrolled for at least one regular semester. However, students can request an Educational Plan, an evaluation of their previous coursework toward a Health Sciences program. The [Educational Plan](#) is a preliminary, unofficial degree plan for advisement purposes and only reflects specific courses toward a health sciences program. Educational Plans are optional and are not required for application to a health sciences program. They are usually completed within 4-8 weeks. An Educational Plan should be requested at least one semester prior to a program application filing deadline if possible.

The School of Health Sciences and the Allied Health Admissions Office reserve the right to accept or reject any coursework completed at other colleges presented for transfer evaluation toward Health Science programs.

Five-Year Time Limit for Select Courses

The RN-BSN program *does not* have a 5-year time limit for courses

Credit by Examination, CLEP and Advanced Placement Credit

Credit through CLEP, High School Advanced Placement (AP) Exams and Credit by Examination may be awarded for a limited number of courses toward Health Sciences programs including MATH 1314, PSYC 2301, and PSYC 2314. CLEP credit is not awarded for ENGL 1301.

Advanced Placement (“AP”) credit for ENGL 1301, PSYC 2301, and MATH 1314 is acceptable if the credit appears on a college transcript as ENGL 1301, PSYC 2301, and MATH 1314 equivalency. A letter grade is not awarded for “AP” credit.

Coursework from Institutions Outside of the United States

Some credits may be restricted or disallowed from colleges or universities outside the United States.

[International Coursework Evaluation](#) is a multi-step process which may take several weeks. **The student must be enrolled in credit classes at a Dallas College campus before the evaluation process can be initiated.**



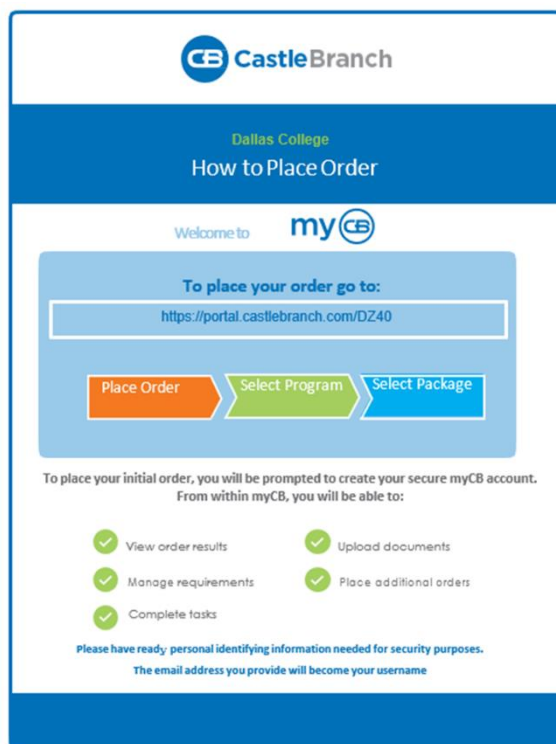
F. CastleBranch

Applicants to the RN-BSN Program are required to have an unencumbered Texas Registered Nurse License, American Heart Association Basic Life Support (BLS) or Advanced Cardiac Life Support (ACLS), drug screen, immunizations, and health insurance. The School of Health Sciences utilizes CastleBranch, a medical record management company, to verify these requirements. Applicants submit this documentation directly to CastleBranch who will verify the completeness of the immunization requirements. Failure to submit this documentation and complete these requirements will result in the applicant's disqualification.

Important Note: Some of the immunizations require multiple doses on a specific timeline over several months. Additional proof of immunizations including titers may be required by hospital clinical sites. The physical exam form, immunization and health records information can be found at [Immunization Requirements](#).

- Navigate the portal by clicking on "Place Order".
- Select RN to BSN Program" package
- Choose "I need to order my Compliance Tracker" first and place the order. You will choose "I need to order my Background Check" once you have been admitted into the program.
- The order process includes you creating an account with your email as the username and you will create your password.
- After you complete the order process, you can visit the site at any time and use the log in you created during the order process.
- You will be able to see your "to-do list" and status of your items within your order.
- You will also have access to FAQ documents, videos and direct support from the CastleBranch user experience team.



G. RN-BSN Application Materials Submission

Potential applicants are required to view an online [RN-BSN Program information session](#) where the program, application procedures, and acceptance policies are discussed in detail. The information session must be viewed as a running Power Point and a link to a questionnaire will activate at the end of the presentation. The applicant is required to complete the questionnaire and upload in CastleBranch as evidence of being complete.

H. Application Filing Period(s)

There are three official filing periods per calendar year for entry into the RN-BSN program:

- **Spring Semester Due By:** November 1st Notification emails sent on or after December 1st
- **Summer Semester Due By:** March 31st Notification emails sent on or after April 14th
- **Fall Semester Due By:** June 1st Notification emails sent on or after July 1st



Applications are accepted year-round. Please refer to the [Dallas College Academic Calendar](#).

Applicants to the RN-BSN Program must meet all [college admission requirements](#) as outlined in the official college catalog.

Individuals who receive an acceptance email are required to return a confirmation within a specified timeframe to verify their space in the class. Failure to return the confirmation by the specified date will result in forfeiture of their space in the program. Notification emails of acceptance, non-acceptance, or disqualification are sent accordingly.

Application materials are not “held over” to the next application filing period. Students who are not selected for admission to the program or students who decline their acceptance may reapply again during the next filing period to be considered for a future admission opportunity.

Curriculum Overview RN-BSN Program

Dallas College RN-BSN Program is a 120-credit hour curriculum comprised of three components: core curriculum courses (general education), lower division courses (primarily associate degree in nursing courses), and upper division BSN courses. Students admitted to the RN-BSN program can complete the program in 12 months, while a part time student can finish in 24 months.

J. RN-BSN Program General Information

1. The Dallas College RN-BSN program accepts a class of approximately 60* students each Spring, Summer, and Fall semester.
*The School of Health Sciences reserves the right to make changes in program enrollment capacity and to determine the minimum enrollment to offer the class each semester.
2. The Dallas College RN-BSN courses are completed online in 8-week semesters. NURS 3301 Health Assessment for the RN, NURS 3340 Population Focused Community Health, and NURS 4465 Leadership/ Management require clinical hours. Students should plan accordingly and be prepared for each clinical experience.
3. The clinical experience component includes:
 - Health Assessment for the RN consists of 32 theory and 48 clinical hours (completed virtually)
 - Population Focused Community Health course consists of 48 theory and 48 clinical contact hours
 - Leadership/ Management consists of 48 theory and 64 clinical contact hours

Prior to clinical experiences the student will complete a Mentor Agreement and a discussion will be initiated by the Academic Chair of the RN-BSN Program regarding possible site locations. All clinical experiences must be in a location that has an affiliation agreement with Dallas College.

The student is responsible for finding possible BSN/ MSN prepared registered nurses (RN) at the clinical site to serve as a mentor. The course faculty has final approval regarding the location for clinical site and the mentor. To stay in compliance with the affiliation agreement, documentation must be provided before the clinical experience begins showing that the student has completed the following: American Heart Association BLS or ACLS, drug screen, immunizations, and health insurance.

4. Applicants to the RN-BSN Programs must submit American Heart Association BLS or ACLS, drug screen, immunizations, and health insurance documentation to CastleBranch. Download more information at [Immunization Requirements](#).

The specific immunizations and screenings are indicated on the health form.

Note: Additional proof of immunizations including titers may be required by hospital clinical experience sites.

5. All applicants must be certified in BLS – Basic Life Support CPR certification or Advanced Cardiac Life Support from CPR certification from the American Heart Association (AHA), Red Cross, or Military-approved mechanism is the only approved CPR course and must be face-to-face or hybrid training. A photocopy of the front and back of the card must be submitted to CastleBranch. The CPR certification must not expire prior to the anticipated program start date and must not expire during a semester when enrolled in the program. CPR classes are available at each Dallas College campus, the American Heart Association, various hospitals, independent instructors, etc.
6. Proof of current personal healthcare insurance coverage is required for all health sciences students. **If documentation of coverage is not submitted to CastleBranch with immunization records, proof of coverage must be submitted by the first day of the semester if a student is accepted to the program.** Students must secure their own coverage and the insurance policy must cover the student at any hospital facility. The National Student Nurses' Association also partners with United Healthcare which offers a student policy for their members. 7. Many of the RN-BSN Program Prerequisite Courses, are offered online. It is recommended to complete the prerequisites in the 5 weeks or 8 weeks session, as this will allow you to get on the journey to begin the RN-BSN upper division courses sooner. Review [Getting Ready for Online Learning](#).
8. **Drug Screening.** All students enrolled in health sciences programs are required by the Dallas/Fort Worth Hospital Council member facilities to undergo a [Criminal Background Check and Drug Screen](#) prior to beginning their clinical experience. Students are responsible for all charges incurred (approximately

\$86.00) for these screenings. **This procedure is conducted *after* a student has been accepted to the RN-BSN Program.**

Results of these screenings are forwarded to the School of Health Sciences for review and verification that a student is eligible to attend clinical experiences. All background check and drug screening results become the property of the School of Health Sciences and will not be released to the student or any other third party.

A clinical affiliate/facility reserves the right to remove a student from the facility for suspicion of substance use or abuse including alcohol. The clinical affiliate/facility reserves the right to request that a student submit to a repeat drug screening at the student's expense on the same day that the student is removed from the clinical facility. Failure to comply will result in the student's immediate expulsion from the clinical facility. Furthermore, regardless of testing or testing results, a clinical affiliate/facility reserves the right to expel a student from their facility.

Note: Should a student who has been accepted to a Health Sciences program be prohibited from attending a clinical experience due to findings of a criminal background check and/or drug screening, the student may be dismissed from the program.

9. Students are responsible for their own transportation arrangements to the college and their assigned facilities for clinical experience.

Clinical Experience

For the NURS 4465 Leadership/ Management course, hospital managers and nurse administrators where the student are employed (or a Dallas College affiliated organization/ facility) will serve as a mentor to the student and work one on one with the student in approving the student objectives and goals for the course assignments. It is the student responsibility to find a mentor and have the mentor sign an agreement. The student both must agree on the leadership or management topic to explore, and then the student will get approval from the student course faculty and the mentor.

With the support of clinical partners, the RN-BSN curriculum encourages students to seek mentors, at their place of employment, for their RN-BSN leadership/ management course; however, if a RN-BSN student is not currently working, Dallas College has identified community leaders that have indicated they will support these students by providing a mentor in their facility.

For the NURS 3340 Population Focused Community Health course, students will follow the direction of the faculty to fulfill the goals for the course assignments.
