<u>Approval of Budget for Richland Collegiate High School (RCHS) for 2018-</u>

The chancellor recommends that the Board of Trustees adopt the attached resolution approving the budget for 2018-19.

The Richland Collegiate High School will enroll its thirteenth incoming junior class this fall. The new proposed budget reflects a projected 5% decrease in enrollment for a total of 600 high school students. Budgeted expenditures have been divided between functional areas to align with the needs of the RCHS. A public hearing on the 2018-19 budget was held on Tuesday, August 7, 2018, as an earlier agenda item.

The proposed 2018-19 budget is \$5,028,366. The estimated expenditures for 2018-19 are in functional areas that relate to TEA categories as follows:
