NOTES TO SCHEDULE OF CURRENT FUNDS EXPENSES BY INDIVIDUAL CAMPUS AND CENTRAL ADMINISTRATIVE FUNCTION

NOTE A - REPORTING ENTITY

The Dallas County Community College District (the "District") was established in 1965 in accordance with the laws of the State of Texas to serve the educational needs of Dallas County and the surrounding communities. The District is accredited by the Southern Association of Colleges and Schools ("SACS"). As the District is accredited on an individual campus basis, SACS requires a review report of current funds expenses in accordance with their current Criteria for Accreditation, issued by SACS Commission on Colleges.

The schedule of current funds expenses by individual campus and central administrative function reflects the operating expenses, excluding depreciation, of the following:

Jan LeCroy Center for Educational Telecommunications)

NOTE B - BASIS OF ACCOUNTING

The accompanying schedule of current funds expenses by individual campus and central administrative function is prepared in accordance with accounting principles generally accepted in the United States of America as promulgated by the Government Accounting Standards Board and the *Annual Financial Reporting Requirements for Texas Public Community and Junior Colleges*, issued by the Texas Higher Education Coordinating Board. The schedule has been prepared on the accrual basis of accounting. However, depreciation is not included as part of this schedule.
